## Terms & Conditions

1. The Boat Owner has provided his/her personal details in Section B of the Visiting Yacht Registration Form, and has requested the RYCT to accommodate the vessel as specified in Section A for which he/she is lawfully authorised to enter into an agreement.
2. Upon the execution of this agreement and prior to the commencement Arrival Date, the Boat Owner shall provide valid credit card details as specified in section D.
3. The RYCT may at any time increase the marina or mooring fees without notice.
4. In principle, this Agreement will commence on the Arrival Date, and will expire on the Departure Date.
5. Requests to extend occupation of the marina or mooring on a casual basis must be made via the RYCT Office. All requests will be considered on a subject to availability basis.
6. The Boat Owner acknowledges by entering into this Agreement that he/she has examined and satisfied him/herself as to the condition and suitability of the marina berth or swing mooring, including but not limited to pontoons, after hours access, and provision of standard electricity and water (if applicable), for the Boat Owner's intended purpose, and the Boat Owner will use the intended berth or mooring at his own risk. The Boat Owner has not relied in any way on the RYCT's skills and judgement.
7. The Boat Owner shall not list or advertise his / her boat for sale without prior consent from the RYCT Office, attempt to assign, mortgage, pledge, sell, change, encumber, sub-let, part with possession, or other encumbrance over the Vessel or any part thereof under this Agreement.
8. The RYCT will not permit commercial operators to enter into a casual berthing agreement.
9. The Boat Owner shall keep and maintain the vessel and its equipment, including ropes and fenders, in good working order and condition.
10. It shall be the responsibility of the owner to provide his/her own mooring lines and warps to moor the vessel in a proper and seamanlike fashion
11. The Boat Owner shall operate and maintain the vessel with due care and diligence
12. The Boat Owner shall comply with all relevant rules pursuant to RYCT By Laws 31 (a) through to (p) (which are available to view via the RYCT Office), rules and by-laws governing or relating to the registration, operation or licensing of the vessel and its equipment.
13. The Boat Owner shall comply with the RYCT's By Laws pursuant to Dogs, By Law 26 (b).
14. The Boat Owner agrees not to employ or engage any contractors to work on the vessel at the RYCT Marina or mooring unless said contractors provide suitable proof of insurance coverage and are licensed and approved by the RYCT Bosun Office prior to any maintenance being conducted.
15. The Boat Owner shall not bring any fuel or hazardous materials into the marina.
16. The RYCT may at its discretion, board, inspect move the vessel and/or its equipment to any marina berth, hardstand or mooring at the Boat Owner's risk and expense. If circumstances permit the RYCT will endeavour to notify the owner of its intentions in this regard.
17. The Boat Owner agrees to comply with and obey any reasonable direction given to it by the RYCT, its General Manager or its duly authorised employees.
